A. <u>Increased Population Estimate for Conservation Trust Funds</u>

Mr. Peak reviewed the Department of Local Affairs' (DOLA) letter acknowledging an adjustment made to the population estimate for 2019 distribution of Conservation Trust Funds (CTF). Mr. Peak submitted and challenged the State of Colorado's original population estimates in January 2021. Based on the data that was sent by Mr. Peak to support the challenge the State has adjusted their population estimates from 640 to 1,055. This change in population estimate should result in the Plains Metropolitan District receiving additional lottery funds in the coming years

Mr. Peak informed the Board that he contacted Tracie Wieland the Manager at Ken Caryl Metropolitan District at the Board's request. The discussion with Ms. Wieland regarding the Plains Metropolitan District's efforts to acquire the Deer Creek Golf Course for open space was non productive.
